I/We, the Guarantor(s), personally, jointly and severally, unconditionally and irrevocably:

- 1 guarantee the due and punctual observance and performance by the Customer of all its financial and other obligations to Rural Livestock Limited;
- 2 agree that, without limiting clause 1 in any way, this guarantee:
 - a. is a continuing guarantee and applies in respect of all present and future financial and other obligations of the Customer to Rural Livestock Limited however they arise;
 - b. applies even when there is a change in Rural Livestock Limited's Terms of Trade or any other arrangements between Rural Livestock Limited and the Customer.
- 3 indemnify Rural Livestock Limited against any loss or liability (including costs), which Rural Livestock may suffer or incur as a result of the Customer failing to duly and punctually observe and perform all its financial and other obligations to Rural Livestock Limited, regardless of whether the Customer's liability is or has become void or unenforceable for any reason and regardless of whether the above guarantee shall be void or unenforceable against me/us, or any of us, for any reason;
- 4 agree that my/our guarantee and indemnity will continue to be binding and at all times enforceable by Rural Livestock Limited even if the Customer dies, becomes insolvent or is placed in liquidation;
- 5 covenant with Rural Livestock Limited that:
 - a. no release, delay or other indulgence given by Rural Livestock Limited to the Customer or any other thing whereby I/we would have been released had I/we merely been surety shall abrogate, release, prejudice or affect the liability of me/us as a guarantor or as an indemnifier;
 - b. as between me/us and Rural Livestock Limited, I/we may for all purposes be treated as the Customer and Rural Livestock Limited shall be under no obligation to take proceedings against the Customer before taking proceedings against me/us;
 - c. I/we will not prove any bankruptcy or liquidation of the Customer in competition with Rural Livestock Limited; and
 - d. any concession, grant of time, waiver, variation or otherwise shall not release me/us from liability.
