### 1. How To Complete the Tender Form

- a.) Your full name and address (as "Purchaser").
- b.) The price you are offering ("Purchase Price").
- c.) Any other special conditions you wish to incorporate in the Agreement ("Special Conditions of Sale").
- d.) You must sign the Agreement ("Signature of Purchaser").

### 2. How to Lodge the Tender

Successful and unsuccessful tenderers will be notified by email and phone by - Tuesday 30<sup>th</sup> September 2025.

Pickup window for successful buyers - Wednesday 1<sup>st</sup> to Friday 3<sup>rd</sup> October 2025.

No returns will be accepted, and the buyer accepts full responsibility for the horse upon purchase, including any issues discovered after the sale.
